# On Amendments in Fares and Handling Fees Due to Consumption Tax Hike

- Amendments to be made to fares and handling fees
- •Applicable for purchases made on April 1\*1, 2014 and onward

Peach Aviation Limited (Peach; Representative Director & CEO: Shinichi Inoue, Head office: Izumisano-shi, Osaka) has today decided to amend its fares and handling fees in line with the increased consumption tax.

The new fares will be applicable to tickets that are purchased at midnight April  $1^{*1}$  and onward. The current fares will continue to be applicable to tickets that are purchased up to and on March 31.

The fare amounts are inclusive of the consumption tax.

#### ■For transitional period following revised rate of consumption tax

The consumption tax is included in Peach's fares. As transitional measures are accepted for the current fares to be applicable for tickets that have been purchased up to and on March 31, 2014 regardless of whether boarding will be on or after April 1, 2014, the current fares and fees will be applied to tickets that are purchased by March 31, and the newly amended fares and fees will be applied to tickets purhased on or after April 1.\*1
